### **INTERNATIONAL TRADE**

#### 6. Three months grace period for SOLAS enforcement

The International Maritime Organisation (IMO) Committee agreed that Administrations and port State control authorities should adopt a practical and pragmatic approach when verifying compliance with the requirements of SOLAS regulations, for a period of three months after 1 July 2016, with a view to:

- Permitting packed containers that are loaded on a ship before 1 July 2016 and are transhipped on or after 1 July 2016 to be shipped to their final port of discharge without the VGM specified in SOLAS regulations
- 2. Providing flexibility to all the stakeholders in containerised transport to refine, if necessary procedures for documenting, communicating and sharing VGM information.

#### 7. Tajikistan delivers acceptance of protocol amending TRIPS agreement

Tajikistan deposited its instrument of acceptance for the 2005 protocol amending the WTO's Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS) on 23 May 2016. Tajikistan's Ambassador, Jamshed Khamidov, presented the instrument to WTO Director-General Roberto Azevêdo.

#### 8. UNECE and WTO Bring Central Asia Closer to the Global Rules-Based Trading System

UNECE, WTO and the Government of Turkmenistan brought together trade negotiators, vice ministers and other high-level officials from SPECA countries - Azerbaijan, Kazakhstan, Kyrgyzstan, Tajikistan and Turkmenistan - as well as their neighbour, the Islamic Republic of Iran, to discuss four key issues: WTO accession; trade facilitation in the region; ways of fostering regional trade; and how countries and development partners can plan and implement the Sustainable Development Goals related to trade.

#### 9. WTO - DG Azevêdo welcomes strong support from APEC ministers for the WTO

At a meeting of APEC trade ministers in Arequipa, Peru (17-18 May), Director-General Roberto Azevêdo welcomed ministers' engagement and their determination that the WTO should keep delivering negotiated outcomes. During their session on 'supporting the multilateral trading system', APEC ministers recognized the significant outcomes agreed at the WTO's 2015 Ministerial Conference in Nairobi and expressed their desire to deliver further results in the years to come - including at the WTO's next Ministerial Conference (MC11), which will be held in 2017.

#### 10. Australia, Singapore Set to Upgrade Trade Deal

Australia and Singapore have agreed on a series of steps to build on their 2003 trade deal, officials announced earlier this month. The measures are in the context of the Comprehensive Strategic Partnership (CSP) work underway between the two sides, which also involves steps to boost defence cooperation. The announcement follows up on an earlier joint declaration from 2015 on the CSP between the two countries, which committed both governments to take a series of steps to build on their economic, trade, and defence ties.

#### 11. EU Trade Ministers Review Next Steps for US, Canada Pacts

The European Commission has confirmed plans to submit a proposal to the European Council in June for signing the 28-nation trade deal with Canada, amid continued questions over the pact's potential fate in the ratification stages.

The news came as part of a meeting of trade ministers from the EU's 28 member states. The Brussels gathering also saw ministers - meeting under the European Council - discuss next steps for the bloc's trade deals with the US, including a new sustainability impact assessment.

# 12. Africa - Approaching the CFTA services negotiations: Which way towards delivery by 2017?

The CFTA negotiations, which were launched in June 2015, will be conducted in two phases. While the first phase covers trade in goods and services, the second phase will focus on investment, intellectual property rights, and competition policy.

Since the launch of the negotiations, the AU Commission (AUC) has been undertaking capacity building seminars to enhance the knowledge and negotiating skills on trade in services among policy-makers, negotiators, and private sector representatives. From these seminars, a general consensus seemed to emerge around the idea that market access and national treatment commitments should be complemented by sectoral regulatory disciplines in order to promote trade competition.

#### 13. Africa - SMEs in the services sector: New drivers of growth in Africa's LDCs?

As conversations about the importance of services to countries' (and especially poor countries') economies resonate throughout the world, the issue of SMEs (small and medium-sized enterprises) and their contribution to the services sector is often raised. Yet the scope and impact of SME-driven services in LDCs have received scant attention in formal academic literature.

Information on SMEs in the services sector in Africa is particularly patchy. However, what is evident from many policy documents, broad economic analyses, business reports, and opinion pieces is that SMEs in the African LDCs face significant hurdles when attempting to develop and market their service offerings, which can be a source of acute frustration and disillusionment, and make the prospect of business success a distant dream.

#### 17. ITF - Transport Sector Unites to Launch Global Decarbonising Transport Project

More than 40 partners and supporting organisations (including FIATA and CLECAT) join ITF for kickoff at global summit of transport ministers. The International Transport Forum (ITF) at the OECD officially launched a major global initiative towards carbon-free transport. Transport activity currently contributes 23% of global CO2 emissions from fossil fuels, with the share expected to rise.

The Decarbonising Transport project is supported by a wide range of stakeholders, including private sector companies, multilateral development banks, intergovernmental organisations, sector associations, NGOs and research institutions. It is anchored in the ITF's Corporate Partnership Board, the organisation's platform for discussions with the private sector.

#### 18. UN discuss Draft Global Aviation Emissions Reduction Scheme

The 191 members of the UN International Civil Aviation Organization (ICAO) discussed a draft resolution to establish a global market-based measure (GMBM) to help meet the sector's goal of carbon neutral growth from 2020 during a meeting held in Montreal, Canada, from 11-13 May. Press reports have it that the meeting remained constructive, with members tabling various proposals in hopes of progress being made, despite the existence of various issues that need to be resolved.
